This Indenture made this 2^d day of July in the Year of our Lord 1826 by and between Sam'l Brake Mary W. Brake and Nancy G. Brake of the County of Southampton and State of Virginia of the one part and Edwin Beale of the same County and State of the other part witnesseth that the said Samuel Brake & Mary W. Brake and Nancy G. Brake for and consideration of the sum of six hundred dollars to him in hand paid by the said Edwin Beale the receipt whereof is hereby acknowledged hath granted bargained and sold and by these presents doth grant bargain and sell unto the said Edwin Beale his lots of dividends of land which was allotted to the said Samuel Brake in the division of the lands of his father Serenelis Brake dec'd and whereas the said Mary W. Brake & Nancy G. Brake before the division and allotment aforesaid held sole and convey'd to the said Samuel Brake all their right title interest and claim whatsoever of or to the tract of land belonging to the estate of their dec'd father Serenelis Brake dec'd This Indenture therefore further witnesseth that the said Mary W. Brake and Nancy G. Brake together with the said Samuel Brake hath granted bargained and sold and by these presents do grant bargain and sell unto the said Edwin Beale the aforesaid his pieces parcels and lots of land distinguished and known in the plott of the division of the said land which formerly belonged to Serenelis Brake dec'd by lots No 3 & 5 and bounded as follows to wit lot No 3 beginning at the corner of lot No 2 on the lower line thence along the said line S 81 E 59 pole to the corner of the lower line thence N 5 E 136 poles to the mill swamp thence up the said swamp to the Mill pond thence up the said pond to the corner of No 2 thence along the line of No 2 S 14 30 E 175 pole to the beginning Lot No 5 beginning at the corner thake of the lower line thence along the said line South S 45 E 10 pole to a stake thence S 80 E 190 pole to the swamp thence down the various course of said swamp to the mill swamp thence up the said swamp as it meandered to the corner of No 4 thence along the line of No 4 S 89 20 W 19 8 pole to the beginning reference being had to the plat and report of the division of the lands of Serenelis Brake dec'd which is of record in the Clerks office of the County Court of Southampton the same will more fully appear together with all houses out houses buildings Yards gardens orchard ways waters and watercourses hereditaments and appurtenances and every part and parcel thereof to him the said Edwin Beale his heirs and assigns forever To have and to hold the aforesaid lots or parcels of land unto the said Edwin Beale his heirs and assigns forever with all houses out houses ways waters Yards gardens buildings improvements and privileges and every part and parcel thereof and the said Samuel Brake and Mary W. Brake and Nancy G. Brake for themselves their heirs executors and administrators by these presents forever warrant & defend the right and title of or to the aforesaid lots or parcels of land and every part and parcel thereof unto the said Edwin Beale his heirs and assigns forever against themselves the said Samuel Brake Mary W. Brake & Nancy G. Brake and against their heirs executors and administrators and against all and every person or persons claiming the same or any part thereof. In witness whereof the said Samuel Brake Mary W. Brake and Nancy G. Brake have interchangeably set their hands and affixed their seals the day & year first written
