 of which the said Thomas Barnes and all his legal representatives are forever released, exonerated  
 and discharged have granted, bargained, sold and do hereby grant, bargain and sell unto the  
 said Thomas Barnes his heirs and assigns as follows that is to say the said Benjamin  
 Morrell have granted, bargained and sold and do hereby grant, bargain and sell unto the  
 said Thomas Barnes his heirs and assigns one certain tract or parcel of Land it being that  
 which was formerly owned by Samuel Woodard dec<sup>d</sup> the same lying and being in the aforesaid  
 County of Southampton and supposed to contain about one hundred acres of Land also  
 all right title interest and estate which he the said Benjamin Morrell in right of his  
 wife Nancy had in and to the negro slaves allotted and assigned to Sally Woodard  
 widow and relict of John Woodard dec<sup>d</sup> as her dower in the same To have and to hold  
 the said tract or parcel of Land and interest in the slaves above described and all and  
 singularly the appurtenances thereunto in any manner belonging and all the right  
 title interest and estate whatsoever to both land and slaves of him the said Benjamin  
 Morrell of us and to the said Land and slaves to him the said Thomas Barnes his heirs  
 exec<sup>s</sup> adm<sup>s</sup> and assigns forever to the only proper use and behoof of the said Thomas Barnes  
 his heirs exec<sup>s</sup> adm<sup>s</sup> and assigns forever In Trust nevertheless that if the said Benjamin Morrell  
 his heirs exec<sup>s</sup> adm<sup>s</sup> shall well and truly pay to the said Jacob Barnes his Executors adm<sup>s</sup>  
 or assigns the aforesaid sum of three hundred dollars and fifty Cents with the interest which  
 shall have accrued thereon on or before the said Jacob Barnes his heirs exec<sup>s</sup> adm<sup>s</sup> shall or  
 may require the said payment that then this Indenture and every thing herein contained  
 is to be void and of none effect but if the said Benjamin Morrell his heirs exec<sup>s</sup> adm<sup>s</sup>  
 shall or do not pay the said sum of three hundred dollars and fifty Cents with the interest  
 which shall have accrued thereon on or before the time the said Jacob Barnes his heirs  
 exec<sup>s</sup> adm<sup>s</sup> may or shall require the same then upon the request in writing either  
 of the said Jacob Barnes his heirs exec<sup>s</sup> adm<sup>s</sup> or assigns or of the said Benjamin Morrell  
 his heirs exec<sup>s</sup> adm<sup>s</sup> the said Thomas Barnes shall and may sell and dispose of the said tract of  
 Land and interest in the said slaves described as aforesaid or such part thereof as may be  
 required for the payment of the said sum of money and interest and Cents at public auction  
 for ready money at the Court House giving at least twenty days previous public notice of the  
 time and place of such sale by advertisement posted up in at least three public places  
 in the said County and that the proceeds of such sale after paying and satisfying all costs atten-  
 ding the execution of this Trust be applied by the said Thomas Barnes to the discharge of the aforesaid  
 sum of three hundred dollars and fifty Cents due and owing to the said Jacob Barnes or assigns  
 or so much thereof as may then be due together with the interest which shall have accrued  
 thereon and any surplus of money then after remaining in the hands of the said Thomas Barnes  
 is to be paid over to the said Benjamin Morrell his heirs exec<sup>s</sup> adm<sup>s</sup> or assigns in case any  
 part of the said Land or interest in the said slaves shall remain unsold at the time of the payment  
 of the said sum of money interest and Cents the said Thomas Barnes is to release to the said  
 Benjamin Morrell all the title therein hereby transferred to him and in case the said Thomas  
 Barnes shall die before the execution of this Trust his heirs exec<sup>s</sup> adm<sup>s</sup> are to carry this Indenture into  
 effect and operation and the said Benjamin Morrell for himself his heirs exec<sup>s</sup> adm<sup>s</sup> and  
 assigns covenants with the said Thomas Barnes his heirs exec<sup>s</sup> adm<sup>s</sup> and assigns the aforesaid  
 tract or parcel of Land and one seventh part at being the interest in the said slaves against  
 the Claims and Claims of all and every person and persons whomsoever well by their  
 presents warrant and forever defend the right and title of the said Land and one seventh  
 part of the said slaves his interest therein unto him the said Thomas Barnes his  
 heirs and assigns forever In testimony whereof the said parties have hereunto sub-  
 scribed their names and affixed their seals on the day and year herein first before  
 us the undersigned signed sealed acknowledged and delivered in presence of  
 Jonathan Tappan John Barnett
