This Indenture made this 14th day of February 1827 Between Martha Davis of the County of Southampton of the first part and Thomas I Davis and Thomas Pittle of the aforesaid County of the second part That the said Martha Davis for and in consideration of the sum of Two hundred dollars to be paid on the following manner to wit One hundred dollars on the 25th day of December 1827 and the remaining four hundred dollars to be paid annually each every 25th December for the true payment of which the said Davis and Pittle have executed their Bond and for the further consideration of the said Davis and Pittle loading the said Martha Davis four years hath Wrote leased and to farm let her plantation called the Island lying and being in the County of Southampton also hath hired the following slaves to wit Michael Sam Phillis and Amos Randolph Melly Ella and Nancy also all the stock of Horses Cattle and Hogs now on the plantation she the said Martha Davis to find a sufficiency of provision for the support of the negroes and stock on the plantation the present year for the term of five years or until the 25th day of December 1831 at the expiration of the said lease the said Davis & Pittle bind themselves their heirs &c to deliver the said plantation to the said Martha Davis in as good order as they received it also all the negroes and stock that may be living at the time and the said Thomas I Davis and Thomas Pittle are to leave a sufficiency of victuals for the support of negroes and stock for the year 1832 when their lease will expire and the said Martha Davis binds herself her heirs &c not to disturb the said Thos I Davis and Thomas Pittle in the quiet possession of the tract of Land slaves or stock aforesaid during the lease aforesaid In witness whereof the said Martha Davis has hereunto set her name and affixed her seal the day and year above written
