This Indenture made the first day of March in the Year one thousand eight hundred and twenty seven between John Parr & Mary Ann his wife of Super County of the one part and Henry Harrison of Southampton County of the part, Witnesseth, that for and in consideration of the sum of one thousand and fifty dollars to the said John Parr & Mary Ann his wife in hand paid the receipt whereof is hereby acknowledged, have bargained and sold by these presents do bargain and sell unto the said Henry Harrison their undivided one eighth of the Land of which the father of the said Mary Ann did seized and possessed containing three hundred and eleven acres be the same more or less lying and being in the County of Southampton on the North side of the Poplar Swamp, together with all and singular the several rights touching the Dower thereof and every part and parcel, which are hereby duly conveyed bargained and sold unto the said Henry Harrison and his heirs forever. In Testimony whereof the said John Parr and Mary Ann his wife have hereunto set their hands and seals the day and date above written.

That for and in consideration of the sum of three thousand Dollars of good and lawful money of Virginia to him the said Humphrey Drury by him the said Samuel paid and satisfied the receipt whereof is hereby acknowledged him the said Humphrey have bargained sold and conveyed and do by these presents bargain sell convey and confirm unto the said Samuel all the right title and interest in a certain tract or parcel of Land ly in the County aforesaid. which Land as sold and conveyed by the said Samuel Drury and Mary Ann his wife late Mary Ann Butler orphan of William Butler dec. to the said Humphrey Drury which will be found in the said conveyance all the Land the said William Butler dec. possessed or claimed to have and to hold the said premises with all the improvements and appurtenances in anywise belonging thereto unto him the said Samuel.
