This Indenture made this 19th day of November one thousand eight hundred and twenty seven by and between Jesse Darden & Priscilla Darden his wife of the County of Southampton and State of Virginia of the one part & Jesse Parker of the County and State aforesaid of the other Part. Witnesseth that they the said Jesse Darden and Priscilla Darden his wife for and in consideration of the sum of one Hundred Dollars to them in hand paid by the said Jesse Parker at or before the writing & delivery of these presents the receipt whereof they the said Jesse Darden and Priscilla Darden his wife do hereby acknowledge and themselves to be their with sales full contracted and paid hath granted bargained sold aliened confirmed and by these presents do grant bargain sell alien and confirm unto him the said Jesse Parker his heirs and assigns forever a certain tract or Parcel of Land lying in the County of Southampton bounded as follows Beginning at a lightwood stake in a corner of Joshua Gardner's line there on East Corner by a line of marked trees to the Indian Branch to the Moon's line thence down said branch to Jesse Parker's line thence along a straight line of marked trees to the said Joshua Gardner's line and thence to the first station containing by estimation Twenty five acres to the same more or less together with the reversion or reversions remainder & remainments issues and profits thereof. To have and to hold the said bargain premises with the appurtenances and advantages of every kind whatsoever to the end to belong to him the said Jesse Parker and his heirs and assigns forever and they the said Jesse Darden and Priscilla Darden his wife their heirs Executors and administrators do and will by these presents mutually forever defend the said bargain premises with the appurtenances and advantages against the lawful claims of all and every person or persons whatsoever and him the said Jesse Parker his heirs and assigns forever In testimony whereof they the said Jesse Darden and Priscilla Darden his wife have hereunto set their hands and affixed our seals this day & Year first above written
