of the second part Witnesseth that whereas the said James Greswatt did execute a note unto
Frederick Cobb for the sum of fifty Two Dollars & thirty six cents & made payable the
10th day of January 1828 and in order to secure the payment of the said debt the said
James Greswatt did execute a deed in Trust to the said Jacob Darden on a certain tract
or parcel of land containing Fifty six acres which is on Record in the Clerk's Office of South-
ampton County and bearing date the 24th day of May 1826 to wit this Indenture Witnesseth
