

William Blow his heirs exec or adm. the following property to wit one certain Tract or parcel of Land containing by estimation, Eighty acres to the same more or less lying in the County of Southampton it being the same tract of land ^{as parcel} whereon the said James Gray now resides and negro man Jacke The Howard to hold the said tract of land and negro man Jacke to him the said William Blow his heirs exec and adm and the said James Gray for himself his heirs exec. adm with hereby covenant and agree with the parties hereto to warrant and defend to the said William Blow his heirs exec adm and the said James Gray to the said land & negro Jacke The Howard nevertheless and upon this express condition that if the said James Gray shall fail to pay & discharge the aforesaid Bond amounting to the aforesaid sum of one thousand and ninety four dollars and fifty cents whether the same shall become payable or shall the said Miles Cook and Henry Kindred at any time conceive themselves in danger of suffering in any wise from the aforesaid security then the said William Blow at the request of the said Miles Cook and Henry Kindred shall set up and sell for cash to the highest bidder at any place (designated by the parties hereto within the County of Southampton) the aforesaid tract of land and negro Jacke and out of the proceeds of such sale first pay to the said Miles Cook & Henry Kindred the amount of the aforesaid Bond amounting as aforesaid to one thousand and ninety four dollars and fifty cents and also the expenses attending the execution and Recording this Indenture and if any surplus remains after paying the aforesaid sum & paying the said James Gray his heirs & adm. but if on the other hand the said James Gray shall will and truly pay and discharge the aforesaid Bond amounting as aforesaid to the aforesaid sum when the same shall become due or when he the said Gray shall be by the said Cook and Kindred be requested to give them sufficient security for the payment of the same then this Indenture and every thing herein contained shall be void and of none effect and the said James Gray further covenants and agrees to render up said Land and negro Jacke to said William Blow when he shall be requested by the said Miles Cook and Henry Kindred so to do if they shall reasonably conclude that they shall or may suffer by the security then aforesaid and the said Miles Cook and Henry Kindred on their part covenants to and with the said James Gray to let the said Land & negro Jacke remain in quiet possession of him the said Gray until they or he shall suffer or be likely to suffer in consequence of the aforesaid securityship In Testimony whereof the parties hereto have hereunto set their names & affixed their seals this 15th day of Decr. 1827
