his Exors adm^r out of the proceeds of such sale of the said slave or slaves will
well and truly pay unto him the said Francis & Charles his Exors adm^r
or assigns the aforesaid sum of one hundred and twenty five Dollars & some
Cents. with any interest thereon from the date of the proceeds after satisfying the
charges thereof and all other expenses attending the Execution of this Indenture
mentioned as aforesaid And in further Trust that until such sale and
conveyance shall be made it shall be lawful to and for the said Joseph
Darden his Exors adm^r to hold and use the said granted ~~property~~
negro Slaves and all future increase that may be and to take and receive
the rents and hires of the said negro Slaves and future increase that may
be to his own proper use and benefit And that in case of the sale thereof
for the purposes aforesaid he the said Joseph Darden his Exors adm^r
shall and will on the request. tender & deliver up the said negro Slaves and
all future increase that may be and do all such acts and things legal and
lawfully execute all such acts or other writings as may or shall be required
him or either of them required for putting the Purchaser or purchasers of the said
negro Slaves and all future increase that may be in actual possession of the
same And for securing and confirming such purchaser or purchasers that
him and assigns and to each of them a good sure perfect and absolute
title And also that the said Joseph Darden his Exors adm^r
will discharge all Taxes impositions and assessments and other charges
whatsoever which may or shall be payable for the said negro Slaves and future increase
that may be or shall be and chargeable thereon during or their possession thereof
the said Joseph Darden for himself and his Exors doth hereby
Covenant and agree to and with the said Alfred his Exors adm^r
that he the said Darden and his Exors attend and defend and pay the costs
negro Slaves and all future increase that may be against the claim or claims
demands or demands of him the said Darden his Exors adm^r or assigns
against the claim or claims demands or demands of all and every
person or persons whatsoever well warrant and by them presently
