 grant unto the said Elizabeth Blom her heirs executors assigns all the right title and demand
 I have in the land and plantation whereon I now live also all the right title and demand
 I have in the land my late husband William Holliman bought of the Legatee of John Hartwell
 also all the right title and demand I have to the following slaves namely one negro man Simon
 one negro boy Tidman one negro boy Ben one negro boy Matthew one negro boy John one negro boy
 and one negro woman Thelma one negro girl Caroline also all the right & title I have to the two
 horses on said plantation also two breeding sows 15th month and fourteen pigs three fowls two
 stags furniture two pine chest one painted seven rush bottom Walnut Chair two pine tables
 one pine safe painted two cotton wheats one flax disto two pair cotton cards two pair wool disto two looking
 glasses four earthen dishes twenty four earthen plates five earthen bowls 12 dozen cups & saucers
 one milk pot one sugar dish one two pot one or iron pot three pint hat one large porter pot
 12 dozen dinner table spoons 12 dozen dinner spoons four waiters one tin coffee pot one bathing tub
