This Indenture made and entered into on the 25th day of August in the year of our Lord one thousand eight hundred and twenty eight by and between Henry Barrett of Southampton of the one part and Thomas Barnes of the said County of the other part, witnesseth that the said Henry Barrett do for and in consideration of the sum of three hundred and ninety dollars to him in hand paid by the said Thomas Barnes at and before the making and delivery of these presents the receipt whereof is hereby acknowledged to the said Henry Barrett his heirs and assigns and by these presents do hereby sell unto the said Thomas Barnes his heirs and assigns a certain tract or part of a tract of Land it being that part of the tract of Land which Jordan Barnes did seized and possessed which was allotted unto the said Henry Barrett by Commissioners acting under a last decree of the County Court for Southampton in the division of the said Jordan Barnes Land between his two sons namely Henry and Bennett this allotment to the above named Henry Barrett is supposed to contain about one hundred and fifteen acres but understood by the above named parties to matter not whether more or less the same being bounded by the lines of the following named persons (to wit) the dividing line made by the Commissioners aforesaid setting apart to Bennett Barrett his lot that being a line by the said Commissioners made which may appear by reference to their report if made or when made by the Lands of Catharine Barrett the lands of the above named Thomas Barnes the Land of William Whitfield's line the land of John Whitfield then again binding with Land of the above named Thomas Barnes to a corner tree which tree was formerly a corner for said Henry Barrett for the above named Thomas Barnes in the line formerly Jordan Barnes' now forming a corner between the above named Henry Barrett and Bennett Barrett At the end of the dividing line between the said Henry and Bennett Barrett made by the above named Commissioners and hereby made the line between the above named Thomas Barnes and Bennett Barrett To have and to hold the above described Land and every part and parcel of the same and all the right title interest and estate which to the said Henry Barrett has heretofore held in and to the said land to only proper use and behoof of him the said Thomas Barnes his heirs and assigns forever and the said Henry Barrett do for himself his heirs and assigns hereby relinquish all present and estate whatsoever of his right title said Land unto him the said Thomas Barnes his heirs and assigns forever free from the claim of him the said Henry Barrett and also free from the claim of all and every person whomsoever and also well and do by these presents warrant and defend a good and right in and to the above described Land to him the said Thomas Barnes his heirs and assigns forever In Testimony whereof I the above named Henry Barrett have hereunto set my hand and affixed my seal this the day and year herein first written Signed sealed acknowledged & delivered as the act and deed of the above named Henry Barrett in the presence of
