This Indenture made this the sixth day of January 1829 the thousand eight hundred and twenty
nine between Popper Murdaugh Alldridge Jones and Spradley Williams of the first part Henry
Smith of the second part whereas the said Alldridge Jones on the 1st of August 1825 in order to
secure the said Spradley Williams his sureties certain bonds and executed in the said deed of
Trust had a duly executed and set forth by Indenture of that date did convey to the said Popper
Murdaugh the tract of Land on which he now resides with the things fallow and things
situate all the appurtenances upon Trust for the use and purposes of the said bond and
mentions and returns since the execution was a delivery of the said deed of Trust the said
Alldridge Jones by deed of bargain and sale duly recorded hath conveyed the said tract
of Land to the said Henry Smith for valuable consideration and whereas the
said Spradley Williams is willing to surrender and yield up the same the said tract of Land
which the said deed gave him NOW This Indenture doth witness that for and in con-
sideration of the premises and also in consideration of one dollar in hand paid to the
said Popper Murdaugh by the said Henry Smith at or before the executing or delivery
of these presents the receipts whereof is hereby acknowledged by the said Popper Murdaugh
and Alldridge Jones with the assent of the said Williams signified by his being a
party to these presents have given granted bargain and sold released and confirmed
and by these presents do give grant bargain sell release and confirm unto the said
Henry Smith the tract of Land with the things and appurtenances as at or in the said deed of
Trust mentioned together with all the crops of corn and other made on the said land the last year
with all the estate right title interest claim and demand both at Law and in Equity which the said Popper
Murdaugh and Alldridge Jones or either of them have at last or hold or possess with the said tract
of Land To have and to hold the said tract of Land to the said Henry Smith his
heirs and assigns forever to the only proper use and behoof of him the said Henry Smith
his heirs and assigns forever and the said Popper Murdaugh and Alldridge Jones
for themselves their heirs Executors paid the said tract of Land as full and
ample a manner as the same was warranted by the said Alldridge Jones to the said
Popper Murdaugh by the said deed of Trust do warrant to the said Henry Smith against
the claims claims of them the said Popper Murdaugh and Alldridge Jones and all persons
whatsoever claiming by through or under them or either of them NOW Witness the hands of the
parties to these presents hereunto set their hands and affixed their seals the day &
