This Indenture made this the sixth day of January of the thousand eight hundred and twenty nine
between Stephen Murdough Attorney for Jones and Spratley Williams of the first part Henry
Smith of the second part whom also he and Attorney for Jones on the 15th August 1828 in order
to secure the said Spratley Williams his surety for certain bonds and executions in the sum due of
delivered to H.J. Smith particularly recite and set forth by Indenture of that date to the sum of twelve hundred
and twenty five dollars the tract of Land which he now resides upon the same Henry Jones being
which all the appurtenances upon trust for the uses and purposes hereinabove mentioned
mentioned and whereas since the execution and delivery of the said deed of trust the said
Attorney for Jones by act of bargain and sale duly recorded hath conveyed the said tract
of Land to the said Henry Smith for valuable consideration and whereas the
said Spratley is willing to convey and yield up the services the said tract of Land
which the said deed gave him now this Indenture witnesseth that for and in con-
sideration of the premises and also in consideration of one dollar in hand paid to the
said Stephen Murdough by the said Henry Smith at or before the executing and delivery
of these presents the receipt whereof is hereby acknowledged by the said Stephen Murdough
and Attorney for Jones with the assent of the said L Williams signified by his signature
hereby to these presents have given granted bargained and sold remise released and confirmed
and by these presents do give grant bargain sell remise release and confirm unto the said
Henry Smith the tract of land above the Party and Appurtenances as in the said deed of
Trust mentioned together with all the crops of corn and other made on the said land to last of year
which all the Estate right title interest claim and demand both at Law and in Equity which he said Stephen
Murdough and Attorney for Jones or either of them have or hold or shall have in the said tract
of Land to have and to hold the said tract of Land to the said Henry Smith his
heirs and assigns forever to the only propriece and behoef of him the said Henry Smith et
Spratley his heirs and assigns forever and the said Stephen Murdough and Attorney for Jones
for himself with his Execution paid the sum tract of Land as full and
ample a manner as the same was warranted by the said Attorney for Jones to the said
Stephen Murdough by the said deed of trust devarant to the said Henry Smith against
the claim or claims of himself and Stephen Murdough and Attorney for Jones and all persons
