It witnesseth that the said Eley Joyner and Nancy his wife Joshua Starred and Marsha his wife in consideration whereof sum of one hundred and twenty five dollars of lawful money of the Commonwealth of Virginia given him and Sally Boyal at or before the sealing and delivery of these presents doth receipt whereof is here by acknowledged have bargained and sold unto these presents doth bargain and sell unto the said Sally Boyal her heirs and assigns one certain Lot or half acre of Land lying and being in the Town of Jerusalem in the County of said and distinguished by the name of said Town by a number twelve and bounded by other Lots agreeable to said plan together with all and singular the houses buildings yards gardens orchards ways waterways watercourses profits commodities advantages emoluments and appurtenances whatsoever to the said land belonging or appertaining to the same used and enjoyed or accepted heretofore taken or known as a part or parcel thereof for the use and profit there of and every part and parcel thereof to have and to hold the said Lot or half acre of Land with all and singular the premises herein before mentioned or intended to be bargained and sold with every of their rights members and appurtenances unto the said Sally Boyal her heirs and assigns forever to and for the only purpose and behoof of her the said Sally Boyal her heirs and assigns forever And the said Eley Joyner and Nancy his wife Joshua Starred and Marsha his wife for themselves and their heirs the said Lot withall and singular the premises before mentioned unto the said Sally Boyal her heirs and assigns free from the claim or claims of them the said Eley Joyner and Nancy his wife Joshua Starred and Marsha his wife or either of them him or either of them and of all and every other person or persons whatsoever shall and will warrant and defend by these presents In witness whereof the said Eley Joyner and Nancy his wife Joshua Starred and Marsha his wife have hereunto sett their hands and seals the day and year first above written
