This Indenture made this 3rd day of October in the year of our Lord one thousand eight hundred and twenty eight Between Wiley Dole and Sally his wife of the one part and Eliza Johnson of the other part all of the County of Southampton kesh of North Carolina and State of Virginia Witnesses that she said Wiley Dole and wife Sally in consideration of the sum of some dollars lawful money of Virginia to them in hand paid by the said Eliza Johnson at or before the making and delivery of these presents the receipt whereof is hereby acknowledged have bargained and sold and by these presents do and each of them bargain and sell unto the said Eliza Johnson his heirs and assigns one certain tract or parcel of Land lying in the County and Parish aforesaid containing by estimation four acres be the same more or less it being a part of the land the said Dole brought of David Keasler and sold to him by Benj. Griffin and others to have and to hold the said four acres of Land which is now prior to the said Eliza Johnson To have and to hold the said land to him and his heirs forever to and for the only proper use and behoof of her the Eliza Johnson her heirs and assigns forever and the said Wiley Dole and Sally his wife for themselves and their heirs with all and singular the premises herein before mentioned unto the Eliza Johnson her heirs and assigns free from the claim or claims of them the said Dole and Sally his wife and of all and every other person or persons whatsover shall and will warrant and for ever defend by these presents In Witness whereof the said Wiley Dole and Sally his wife hereunto set their hands and affixed their seals the day and year first above written
