aforesaid in consideration of the sum of One hundred and eight dollars to him in hand paid or before
the sealing and delivery of the present hath granted bargained sold alienated and confirmed and
by these presents doth grant bargain and sell also to his friend Captain John Elizabeth Crosby
her husband and assigns forever the said town and lot in the Town of Southampton aforesaid of
which the said Thomas Crosby and myself doth have and to hold the said town and lot
with the appurtenances to her the said Elizabeth Crosby her husband and assigns forever And the said
Charles L. Wingfield Marshal as aforesaid for himself his heirs in all others claiming by
thrust or under him but not otherwise the said town and lot with its appurtenances
to her the said Elizabeth Crosby her husband and assigns forever shall and will warrant and
secure against all debts wherof the said Charles L. Wingfield as Marshal
aforesaid hath herunto set his hand and affixed his seal the day and year first above written

This Indenture made this 28th day of March in the year of our Lord Christ on thousand
Eight hundred and twenty nine between Rebecca Rose widow of Samuel Rose deceased
the one party and Jason Rose of the other party both of the County of Southampton, parish of
Matthew and state of Virginia. WITNESSETH that the said Rebecca Rose in consideration
of the sum of Sixty dollars of lawful money of Virginia to her in hand paid by the said
Jason Rose at or before the concluding and delivery of these presents doth receipt whereof it
herself acknowledge hath bargained and sold and by these presents doth bargain and sell
unto the said Jason Rose his heirs and assigns a certain tract or parcel of Land containing
by Estimation six, six and one half acres to the same more or less at term
that portion of land that was assigned over to her for life from the deceased husband
Samuel Rose's Estate together with all and singular the houses out houses and edifices
buildings yards gardens or other lands tenements ways waters and water courses profits com-
monly called her inheritance and appurtenances whatsoever to the said land belonging
to or in any wise appertaining to the same or any part parcel or number thereof or all
belonging to the same or any part thereof and the reversion and reversionary part or
other rents issues and profits therefrom and every part and parcel thereof To have and to hold
the said 5 1/2 acres land with the buildings and all and singular the premises hereinbefore men-
tioned or intended to be bargained and sold with every part and parcel thereof with all her right
title and interest in and to the said tract or parcel of land unto the said Jason Rose
his heirs and assigns forever to and for the only use and benefit of him the said Jason
Rose his heirs and assigns forever and the said Rebecca Rose for herself her living
the said land with all and singular the premises before mentioned unto the said Jason
Rose his heirs and assigns free from all claim or claims of her the said Rebecca Rose
or her heirs and of all and every other person or persons whatsoever shall and will warrant
and for us defend by these presents In witness whereof the said Rebecca Rose hath
hereunto set her hand and seal this day and year first above written
