Witness That Indenture made the 27th day of May one thousand eight hundred and twenty nine between Joseph H. Darden of the County of Southampton and State of Virginia of the first part and Jonathan Scott of the same County and State of the second part and Jonathan W Scott of the County of Southampton and State of Virginia of the third part and Ephraim Darden of the County of Southampton and State of Virginia of the fourth part. Whereof the said Ephraim Darden the said Joseph H. Darden stands jointly indebted by note of hand to the said Jonathan Scott the sum of fifty eight dollars and twenty five cents current money of the United States of America and whereas for the further assurance of the payment of it is agreed by the parties hereto that a conveyance in trust shall be made unto the said Jonathan W Scott for the benefit of the said John Scott of the sum of the note aforesaid shall not be permanently paid with lawful interest thereon or before the first day of September next. Now This Indenture witnesseth that the said Ephraim Darden for and in consideration of the premises and for the further sum of One dollar to him in hand paid the receipt of which is acknowledged hath bargained and sold unto by these presents doth for himself his heirs &c &c grant bargain and sell unto the said Jonathan W Scott his heirs &c the following property viz To wit a head of cattle twenty one head of hogs twelve head of sheep two cart wheels one horse two racks &c and the residue to have and to hold the aforesaid grant and bargained premises unto the said Jonathan W Scott his heirs and assigns not yet former and it is hereby declared to be the true intent and meaning of these presents that if the said Ephraim Darden shall pay to the said Jonathan Scott his heirs or assigns the said sum of fifty eight dollars and twenty five cents and interest agreeable to the tenor of said note to the said Jonathan Scott then the said Jonathan W Scott his heirs and assigns shall hold the said property above granted to the sole and proper use and behoof of the said Ephraim Darden and the said Jonathan W Scott covenants and agrees with the parties hereto that if the said Ephraim Darden his heirs &c &c shall fail to make payment to the said Jonathan Scott his heirs and assigns on or before the first day of September next the sum due on the note aforesaid then the said Jonathan W Scott his heirs and assigns shall stand seized of the above granted and bargained premises following that is to say that at the request of the said Jonathan Scott his heirs or assigns the said Jonathan W Scott his heirs Executors administrators and assigns or either of them shall give ten days notice and sell at public sale the above mentioned goods and chattels and shall pay the money arising therefrom to the said Jonathan Scott his heirs or assigns so far forth as shall be due and after deducting the said note and interest and all the expenses remaining or arising from the notice and sale he shall pay the balance of the money to the said Ephraim Darden or his heirs and assigns if the parties hereto have herein set their hands and seals the day first above written signed sealed and delivered in presence of
