Given the 1st day of May one thousand eight hundred and twenty nine
between Joseph Darden of the County of Southampton and State of Virginia of the
first part and Jonathan Scott of the same County and State of the second part and
John W Scott of the County of Buckingham and State of Virginia a friend of the third part
Witnesseth that whereas the said Joseph Darden stands jointly indebted by note of
hand to the said Jonathan Scott in the sum of fifty Eight dollars and twenty five cents
current money of the United States of America and whereas for the further assurance
of the payment it is agreed by the parties hereto that a conveyance in trust shall be made
over the said Carlton W Scott for the benefit of the said John Scott it is now on this
note aforesaid shall not be punctually paid with lawful interest thereon or before
the first day of September next. Now the said Indenture witnesseth that
the said Joseph Darden for and in consideration of the premises and for the sum
sum of One dollar to him in hand paid the receipt of which is acknowledged
hath bargained and sold and by these presents doth for himself his heirs & executors
et cetera grant bargain and sell unto the said Carlton W Scott his heirs & executors
the following property viz To Head of cattle twenty one head of hoggs
twelve Head of sheep two Cows two Heels one Horse two brackets & two yokes
to have and to hold the aforesaid grantees and bargained premises unto the said Carlton
W Scott his heirs and assigns forever and it is hereby declared to be the true
intent and meaning of these presents that it is the said Joseph Darden shall punctu-
ally pay to the said Jonathan Scott his heirs & assigns the sum of Fifty Eight dollars
and twenty five cents and interest agreeable to the tenor of this note to the said Jonathan
Scott than the said Carlton W Scott his heirs and assigns shall hold the said property above
granted to the sole and proprietors and behoef of the said Joseph Darden and the said
Carlton W Scott Covenants and agrees with the parties hereto that if the said Joseph Darden
his heirs & assigns shall fail to make payment to the said Jonathan Scott
his heirs and assigns on or before the first day of September next the sum due on the note aforesaid
shall remain due to the said Carlton W Scott his heirs and assigns shall stand liable of the aforesaid
and bargained premises following that is to say that at the request of the said Jonathan Scott
his heirs and assigns the said Carlton W Scott his heirs Executors administration and assigns
or either of them shall give two days notice and sell at public sale the above mentioned
goods and chattels and shall pay the money arising therefrom to the said Jon-
athan Scott his heirs or assigns so far forth as shall be due and after discharging the
said note and interest and all the expenses remaining or arising from the note
and sale he shall pay the surplus money to the said Joseph Darden or his assigns
full and complete discharge of the aforesaid sum due to him and shall be bound to do no more
