From the 1<sup>st</sup> of March in the year of our Lord Christ one  
thousand Eight Hundred and twenty nine Between Jason Rose and Elizabeth his wife  
of the one part and Rebecca Rose of the other half all of the County of Southampton parishes  
of Holloway and State of Virginia witnesseth that the said Jason Rose and Elizabeth  
wife for and in consideration of the sum of two hundred and twenty three dollars and  
lawful money of the Commonwealth paid to him in hand by the said Rebecca Rose the  
receipt whereof is hereby acknowledged hath granted bargained sold aliened enfeoffed and  
conveyed and by these presents doth grant bargain and sell unto the said Rebecca Rose  
her heirs and assigns forever a tract or parcel of Land containing by a line running  
one furlong and ninety three acres be the same more or less and bounded as follows at South East Point,  
Beginning at a pine corner between Jason Rose and Rebecca Rose thence at N 22° E 44° 15' S.  
to a pine corner between Jason Rose and Rebecca Rose and Benjamin Williams  
thence S 80° N 112° E 15' to an oak corner between Rebecca Rose and Benjamin Williams  
thence S 27° E 52° S to a small oak thence N 17° E 14° E to a pine thence S 86° E 25° S to  
a small pond thence S 11° E 61° S to a corner in the line of Harrison & Griffin's  
S 70° N 13° E to an oak stump thence S 54° N 118° E to a cedar post thence S 82° N 15° E to a  
sak S 80° N 14° E to a small oak thence S 87° N 17° E to a pine thence S 74° N 10° E to a black  
oak in the trunk prong of the cypress swamp corner between Harrison & Griffin and  
Jordan Berry thence down the run of the Cypress swamp the various corners being  
N 17° E 20° S to a black gum corner between Rebecca Rose and Jackson  
Pankford thence up a small branch thence a corner being S 74° N 15° E to a smooth pine  
corner between Jackson Pankford & Barnes Brown close to the head of the said branch the  
various corners being S 82° E to Rebecca Rose thence S 72° E 23° S thence S 89° E 33° S  
thence S 86° E 11° E to a pine thence S 89° E 13° E to the pine corner between Jason Rose and  
Rebecca Rose and thence to the first station Plantations and all houses and houses Edifices  
buildings yards gardens or charas ways roads and water courses unto the said Esqrs  
belonging or in anywise appertaining unto the same or any part thereof all rights titles  
claims or demands whatsoever of them Jason Rose and Elizabeth his wife their heirs executors  
and administrators of vivantes whoe so ever may part or parcel thereof to have and to hold  
the said plantation tract or parcel of Land with the appurtenances thereto belonging  
or in anywise appertaining unto the said Rebecca Rose her heirs and assigns forever  
and the said Jason Rose and Elizabeth his wife for themselves their heirs executors & administrators  
such hury covenant promises and grants unto the said Rebecca Rose his heirs and assigns  
by these presents shall and will warrant and forever defend all rights and titles what  
soever to the said Land or any part thereof unto the said Rebecca Rose her heirs executors and  
assigns forever against the title claims or demands of any person whatsoever
