This Indenture made and entered into this 28th day of March A.D. one thousand eight hundred and twenty nine between Jason Rorro and his wife of the one part and Ely W. Davis of the other part all of the County of Southampton and State of Virginia WITNESSETH that whereas the said Jason Rorro and his wife doth for and in consideration of the sum of One Hundred and twenty nine dollars and sixty six Cents to him in hand paid by the said Ely W. Davis the receipt whereof is hereby acknowledged grant bargain and sell unto the said Ely W. Davis his husband a signet forever one certain tract and parcel of Land situate by survey one hundred and twenty seven acres the same more or less siting a part of the Drew Williams Tract of Land which the said Jason Rorro purchased at public Auction lying and being in the County of Southampton in Notaway Parish and is bounded as follows (viz) Beginning at a pine a corner between Rebecca Rorro and Ely W.
