Alexander P. Peto the receipt is hereby acknowledged have bargained and sold
and do bargain and sell unto the said Alex^r P. Peto his heirs and assigns one parcel
of the land whereon Elizabeth Porter now resides as her dower which said land or
the undivided part may be allotted to me or my heirs from my father's estate at the death
of the said Elizabeth Porter widow of John Prince dec^d To have and to hold the
said land with the tenements her appurtenances and all and singular other premises
heretofore mentioned with every part and parcel thereof with all its rights and appurtenances
unto the said Alexander P. Peto his heirs and assigns forever and the said William Prince
and Marthe his wife for themselves and their heirs the said land or undivided part thereof
with all and singular the premises and appurtenances before mentioned unto the said
Alex^r P. Peto his heirs and assigns free from the claim or claims of them the said
William Prince and Marthe his wife or either of them heirs and of all and every
person or persons who at any time shall will and do warrant and forever defend
by these presents In Witness whereof the said William Prince and Marthe
his wife have hereunto set their hands and seals this day and year above written
