Section 1 This Indenture made and entered into on the 27 day of September in the year of our Lord one thousand eight hundred and twenty eight by and between Betty Jackson of the first part
Benjamin T. Joseph Ryman of the second part and Jacob Barnes of the third and last part each and all the above named parties having of the County of Southampton in the state of Virginia whom
the said Betty Jackson is in debt to the said Jacob Barnes on the sum of Thirty dollars
appearing by Bond as well as this Indenture and the said Betty Jackson being in debt
and desirous to secure the payment of the aforesaid debt together with the interest which shall
hereafter accrue thereon notwithstanding the said Betty Jackson has no consumption
thereof and for the further consideration of the sum of one dollar to her in hand paid
by Joseph Ryman at and before the making and delivery hereof the receipt of
which is hereby acknowledged and from every part of which the said Betty Jackson
and all her legatees and successors are forever released ^{monetary} and discharged the said
Betty Jackson have bargained and sold and do by these presents grant bargain and
sell unto the said Joseph Ryman his heirs and assigns one certain Lot of land of
land by me in the aforesaid County of Southampton and supposed to contain about ten acres
and bounded by the following named persons land to wit the heirs of Samuel G. C. Williams
James Williams Jr. or the above named Jacob Barnes Sally Price, Abigail Price
and Marion McIntosh To have and to hold the abovesigned Lot of Land of
