Jones and Benjamin Williamson Comprenees appointed by the Comy Court of Southampton to sell the land belonging to the orphans of ^{Robert} ~~Robert~~ ^{deed} of the one part and Jesse Holt of the other part all of the County of Southampton State of Virginia Witnesseth that the said William A. Jones and Benjamin Williamson Comprenees in consideration of the sum of twenty four dollars and twenty four cents lawfully money of Virginia to them on hand paid by the said Jesse Holt at or before the executing of these presents the receipt whereof is hereby acknowledged hath granted bargained and sold aliened and confirmed unto the said Jesse Holt his heirs Execution administration and assigns forever one certain tract or parcel of Land lying and being in the County of South Hampton aforesaid containing by estimation twenty four acres more or less with all and singular the appurtenances therunto belonging and bounded by the land of the said Jesse Holt on the one side by the road and the land belonging to the Estate of John Washam ac^d on the East and North East and Elizabeth Fry on the West to have the said Jesse Holt his heirs and assigns forever to the only proper use and behoof of him the said Jesse Holt his heirs and assigns forever and the said William A. Jones and Benjamin Williamson do hereby themselves and their heirs and assigns Covenant and agree with the said Jesse Holt his heirs and assigns that the said William A. Jones and Benjamin Williamson their heirs and assigns shall and well warrant and forever defend all rights and titles to the above mentioned land unto the said Jesse Holt his heirs and assigns free from the claim or claims of all and every other person or persons whatsover shall well and do demand and forever defend by these presents. This Indenture made and entered into this 29th day of December one thousand Eight hundred and twenty one between Barclay Bryant as trustee to Fowlers deed for the benefit of Jonathan Bryant of the one part and George Camp of the other part. Witnesseth that the said Barclay Bryant for and in consideration of two hundred and thirty dollars current money in hand paid hath bargained and sold and by these presents doth bargain and sell unto George Camp one certain tract of land containing by estimation one hundred and forty two acres as described in a certain deed of trust executed by the aforesaid John Fowler the 2th day of May one thousand eight hundred & thirty one and twenty six by virtue of which deed the said land was on the 22nd Feb^r sold at public auction to the highest bidder To have and to hold said tract of Land with the appurtenances therunto and all and singular the premises and appurtenances therunto for mentioned unto the said George Camp his heirs and assigns forever and the said George Camp his heirs and assigns forever to be bargained and sold with every part and parcel thereof with every of the rights mentioned and appurtenances unto him the said George Camp his heirs and assigns forever and the said Barclay Bryant for himself and his heirs with all and singular the premises and appurtenances aforesaid mentioned as conveyed by said deed of trust unto the said George Camp his heirs and assigns free from the claim of him the said Barclay Bryant and his heirs and of all and every person whatsover claiming under him In Witness whereof the said Barclay Bryant & Jones set their hands and affixed their seals the day and year first above written
