And Indenture made this 15th day of March in the Year of our Lord one thousand eight hundred and thirty between Burrwell Williams Martha Williams the Widow of John Chen Williams Esq^r John Williams and Nicholas Williams all of the County of Southampton of the one part and Solomon Britt of the same County of the other part Witnesseth that the said Burrwell Williams Martha Williams John Williams and Nicholas Williams for and on consideration of the sum of Five Hundred dollars current money of Virginia to them the said Burrwell Williams Martha Williams John Williams and Nicholas Williams in hand paid by the said Solomon Britt at or before the sealing and delivery of these presents the receipt whereof the said Burrwell Williams Martha Williams John Williams and Nicholas Williams doth hereby acknowledge and thereof and therefrom doth acquit and discharge the said Solomon Britt his heirs &c. by these presents they the said Burrwell Williams Martha Williams John Williams and Nicholas Williams have granted bargained and sold and by these presents doth grant bargain and sell unto Solomon Britt and to his heirs assigns forever one certain tract or parcel of land lying and being in the County of James in the land formerly belonging to Spencer R Jenkins supposed to be two hundred acres more or less and bounded as follows is bounded by the lands of John Wyzland John Duff and Black Water and the reversion and reversions remainder and remainders unto heirs and profits thereof and of every part and parcel thereof and all the estate right title interest property claim and demand whosoever of them the said Burrwell Williams Martha Williams John Williams and Nicholas Williams of in or to the same to have and to hold the said tract or parcel of land and whole right title in the said lands with its appurtenances unto the said Solomon Britt and assigns to the only proper use and behoof of Solomon Britt his heirs and assigns forever and the said Burrwell Williams Martha Williams John Williams and Nicholas Williams for themselves their heirs &c. doth hereby covenant and grant to the said Solomon Britt his heirs and assigns that they the said Burrwell Williams Martha Williams John Williams and Nicholas Williams their heirs &c. shall and lawfully shall grant unto the said Solomon Britt his heirs and assigns against the lawful claim or demand of them the said Burrwell Williams Martha Williams John Williams and Nicholas Williams and their heirs &c. against the claim or claims of all or any person or persons dead shall and will by these presents forever warrant and defend.
