This Indenture made this 25th January 1830 between James Jetterson of the first part and Robert Nicholson of the third part Whereas the said James Jetterson is justly indebted to the said Robert Nicholson in the sum of Eight hundred and thirty dollars to be paid on the 27th day of January 1830 as by a Bond bearing date on the 25th of January 1830 in my fully appears which lets with legal interest thereon in millions and denariis according the said James Jetterson to decine Non this Indenture witnesseth that John T Blom for and consideration of the premises and for the further consideration of one dollar of the money of Virginia to the said James Jetterson in hand paid by the said John T Blom at and before the ensing and delivery of these presents the receipt whereof is hereby acknowledged by the said James Jetterson hath given granted my and sold above unfeoffed released and Conformed and by these presents doth give grant bargain sell and release and Conform to the said John T Blom his heirs and assigns forever interest in a certain tract or parcel of Land held by his mother Mary Jetterson sometime by the lands of John McHenry Joshua Brizgus Solomon Parker and the land lying in unto the Estate of Richard P. Gomont also has interest in the following slaves held by his mother Mary Jetterson viz Bessy Webb, Melly and Penruie with all and singular the appurtenances to the said interest in the said Land belonging or in any wise appertaining and also the future increase of the female slaves and all the Estate right title and interest of the said James Jetterson in and to the said granted or intended to be hereby granted above parcel of Land and premises to have and to hold the said hereby granted interest in the said Land and other property before mentioned and future increase of the female slaves hereby conveyed into the said John T Blom his heirs and assigns forever to the only benefit and behoof of the said John T Blom his heirs Executors and Assignees forever And the said James Jetterson for himself his heirs Executors &c doth hereby Convey to the said John T Blom his heirs Executors &c in manner and form following here to say that the said James Jetterson his heirs Executors &c do the aforesaid interest in the Land and other property hereby Convey'd unto the said John T Blom his heirs &c against all persons whatsoever shall and will warrant and forever defend by these presents upon that notwithstanding that the said John T Blom his heirs Executors &c shall permit the said James Jetterson to remain quiet and peaceable possession of the interest of slaves and other property hereby Convey'd and take the profits thereof to his own use till default be made in the payment of the said sum of Eight hundred and thirty dollars into the whole or in part and then upon the further trust that he the said John T Blom his heirs Executors &c shall and will to soon after the happening of such default of payment as he may think proper or the said Robert Nicholson his Executors &c Assignees shall request sell the said interest in the Land and other property hereby Convey'd in full part of the hereby granted premises as the Trustee or his representative hereby authorized to act shall think sufficient for the purpose and shall think proper to see to the highest bidder for ready money at public auction after having fixed the time and place of sale at his own discretion and Convienient note thereof and out of the monies arising from such sale shall after satisfying the charges thereof and all the other expenses attaining the premises pay to the said Robert Nicholson his Executors &c the said sum of Eight hundred and thirty dollars with interest and the balance if any shall pay to the said James Jetterson his heirs Executors but if the whole of the debt shall be fully paid off and satisfied to the said Robert Nicholson his heirs &c on or before the 27th day of January 1831 so that no default be made in the payment of the said debt then this Indenture to have all to remain in force & virtue notwithstanding wheresof the parties to these presents have hereunto set their hands and affixed their seals the day and year first above written signed sealed & delivered in presence of
