This Indenture made this 14th day of April in the year of our Lord one thousand eight hundred and thirty between Thomas J Bristle of Touchampton County of the one part and Robert Daniel of Touchampton County aforesaid of the other part. Witness that the said Thomas J Bristle for in consideration of the sum of six hundred dollars to him in hand paid or second to be paid by the said Robert Daniel before the executing and delivery of these presents the receipt whereof is hereby acknowledged hath bargained and sold and by these presents doth hereby bargain and sell unto the said Robert Daniel his heirs and assigns all his right title and interest in and to a certain tract parcel of land lying and being in the County of Touchampton aforesaid containing by estimation three hundred and twenty five acres be the same more or less and bounded by the lands of Elias Sammuels the lands belonging to the Estate of William Byrd dec^d the land of Samuel B Bristle the land of David B Bristle and the land of John B Bristle all the Mann Plantation which formerly belonged to Arthur Jones dec^d which said Land Thomas J Bristle until his death and the reversion and reversions remainder and remainder equally and other lands and profits thereof and every part and parcel thereof To have and to hold the said tract and parcel of Land with the tenements hereunto and all and singular other the premises therein before mentioned or intended to be bargained and sold and every part and parcel thereof with every other right appurtenant and appurtenances unto the said Robert Daniel his heirs and assigns and the said Thomas J Bristle for himself and his heirs the said tract of land with all and singular the premises the premises and appurtenances before mentioned unto the said Robert Daniel his heirs and assigns free from the claims or claims of him the said Thomas J Bristle and his heirs assigns and of all and every person or persons to whomsoever shall well and do command and defend by these presents.
