Witnesseth that for and in consideration of the sum of one hundred and fifty dollars to me in hand paid by the said Nathaniel Francis aforesaid I the said Drury Biddle have given grant bargain and sold and do by these presents give grant sell make over and convey unto the said Nathaniel Francis and assigns the aforesaid negro slaves Coni Jacob & Nancy upon trust and upon this express condition that should the said Bond or Note be made as aforesaid be due and unpaid so as the holder thereof should be unable to satisfy the same for the recovery of the debt or sum of money thereby due or at any future period should the said Nathaniel Francis or any of his heirs or assigns be in danger of suffering any inconvenience by reason of the securityship aforesaid that then and in that event it shall be lawful and is hereby declared to be the true intent and meaning of these presents for the said Nathaniel Francis or assigns at the request of the said Drury Biddle or Nathaniel Francis or their representatives to expose to sale the aforesaid negro slaves Coni Jacob and Nancy at the Court House of the County aforesaid for Cash after giving at least ten days public notice thereof and of the proceeds of such sale first pay and discharge all sums of money which the said Nathaniel Francis may have paid or shall pay which he shall or may be bound to pay in consequence of the securityship aforesaid together with the accruing interest thereon also all cost and charges incidental hereto and the balance if any pay over to the said Drury Biddle or his assigns taking a receipt therefor To have and to hold the said negro slaves Coni Jacob & Nancy unto him the said Nathaniel Francis and assigns as Trustee aforesaid to and for the purposes aforesaid and on the way and manner aforesaid and it is hereby covenanted and agreed between the parties that in case the said Bond or Note should be paid and discharged and the said Nathaniel Francis thereby exonerated from the securityship aforesaid that then and in that event it shall be lawful for the said Nathaniel Francis as Trustee aforesaid and he is hereby required to give acquittances make releases and discharges so as the aforesaid property shall be released from this incumbrance and stand and be to the said Drury Biddle as though this Indenture have never been written To all of which the parties hereto do hereby declare to do and perform and to be the true intent and meaning of these presents.
