hundred and thirty Between Moses Teller of the first part William M Culler the Trustee of the

of Virginia Whence the said Moses Teller stands party indebted to the said Joseph Jordan
summons by Writ bearing even date with these presents in the sum of forty eight dollars and 33 cents.

remaining due and to secure him this instrument which shall be an acknowledgment of the sum
of one dollar of lawful money of Virginia to the said Moses Teller in hand paid by the said

sold aliened uncoffred released and confirmed and by these presents doth give grant bargain
sell alien uncoffred release and confirm to the said William M Culler his heirs and
assigns for ever the following personal property to wit one Bay horse named Billy One
Cart and wheels present Crop of Corn broken past Oaten &c together with all the
right title and interest of the said Moses Teller in and to the above mentioned personal
property hereby granted or intended to be hereby granted or intended to be hereby granted
To have and to hold the said hereby granted or intended to be hereby granted personal
property as above mentioned unto the said William M Culler the Trustee his heirs and
administrators and assigns forever to the only use and behoef of the said William M Culler
Culler his heirs Executors administrators and assigns forever and the said Moses Teller
hereby his heirs Executors administrators with hereby covenant promise and agree to and
with the said William M Culler his heirs Executors administrators and assigns forever
that the aforesaid personal property hereby conveyed unto the said William M Culler his
heirs Executors administrators and assigns against all persons whatsoever shall and will remain bound from
defend by these presents upon pain nevertheless that the said William M Culler his heirs
Executors and administrators shall permit the said Moses Teller to remain in quiet and peaceable pos-
session of the said personal property hereby conveyed until default be made in the payment of the said
sum of Forty Eight dollars and 33 cents either in the whole or in part and then upon the fur-
ther trust that the said William M Culler or his heirs Executors administrators and assigns shall and
will do soon after the happening of such default of payment as he or they may think proper
or the said Joseph Jordan his Executors administrators and assigns shall request sell all
the aforesaid personal property hereby conveyed or such part thereof as the said Trustee or
his representation hereby authorized to act shall think sufficient for the purpose and shall
think proper to sell to the highest bidder for ready money at public auction after having
fixed the time and place of sale at this instrument no given at least ten days previous
public Notice of the time and place of such sale by advertisement posted up at three
or more public places in the neighbourhood and out of the towns arising from such
sale shall after deducting the charges thereof and all other expenses attending the inc-
onition of these presents pay to the said Joseph Jordan his Executors administrators and assigns
