Rochelle This Inventory made and entered into the 17th day of March 1830. One thousand Eight hundred and
 thirty between Nathaniel Rochelle of the County of Southampton and state of Virginia of one
 Plaintiff and John Denegre of the same state and County of the other part. witnesseth that whereas
 Esquires and the said Nathaniel Rochelle stands partly indebted to the said Pierce in the several sums
 Delivers to of money to wit One Note bearing date the day of 1828 and due the 25th day of
 December 1828 for the sum of four dollars and dollars which note is to be paid
 18th June 1832 Edwin Boykin. Also One Note bearing date the 18th day of June 1829 and payable the 25th day
 of December 1829 for the sum of Four Dollars and fifty cents also One Note also
 Note bearing date 18th June 1829 and payable the 25th November 1830 for the sum of Four
 Dollars and fifty cents and 33 Cents. Also One other Note dated the 21st January 1829
 and payable on day after date for twenty four dollars and 8 cents and being settled and
 desirous of securing to the said Pierce his heirs &c the said several sums of money above
 mentioned with all lawful interest which may accrue therefrom and as well as for and in
 consideration of the sum of one dollar in hand paid by the said John Denegre at Tuckahoe
 said Pierce the receipt whereof hereby acknowledge & have granted bargained sold conveyed
 and confirmed and do by these presents grant bargain sell convey and confirm unto the said
 John Denegre his heirs &c One certain tract or parcel of Land lying and being in the County of
 Southampton Virginia adjoining the lands of Nathan Bryant Blumy Morris and others and aforesaid conveyed
 the Land which the said Pierce purchases of Francis Evans and others and aforesaid conveyed
 by deed to the said Rochelle called and known by the name of the Machmo Tract Containing by Survey
 Two hundred and eighty eight acres more or less also the following Negro slaves to wit negro man Nancy
 Kitchen one man named Jack and one man named Elam To have and to hold all and singular
 land the said granted land and premises together with all the other property above mentioned
 unto the said John Denegre as trustee as aforesaid and his heirs and assigns upon Trust and
 this express condition that if the said Nathaniel Rochelle his heirs &c doth default
 pay and satisfy the said Pierce his heirs &c the said several sums of money above mentioned
 when the same may be come due or owing that then the said John Denegre his heirs
 and assigns shall and may at the request of either of the parties or whenever the said Pierce his
 heirs &c may think proper and direct sell at public auction for cash by first advertising
 the same at two or more public places in the County aforesaid giving at least twenty days notice
 of the time and place thereof all or any part of the said granted land and premises and
 property above mentioned and out of the proceeds thereof first pay and satisfy the said Pierce
 his heirs &c the said several sums of money above mentioned together with all legal debts
 which may accrue from carrying the same into effect and the surplus of any pay and satisfy
 Rochelle his heirs &c and the said Nathaniel Rochelle for himself his heirs &c doth make
 up with such further compensation as agree to and with the said John Denegre his heirs
 and assigns and further covenant and agree to and with the said John Denegre his heirs
 and assigns and defend the right title and interests of the above mentioned land
 premises and other property as aforesaid unto the said John Denegre his heirs &c and assign
 the claim and demand of any other person or persons claiming the same notwithstanding
 the said Rochelle and Denegre had heretofore set their names and affixed their hands to aforesaid
 above mentioned legend and seal and acknowledge in presence of
 John Jackson John R. Williams (Subscribed and attested)
