Parker wife of William Bryant made and entered into on this eleventh day of October in the year of our Lord one thousand eight hundred and thirty seven William Parker and Polly his wife of Hertford County State of North Carolina and Lucy Brown of the County of Southampton and State of Virginia of the first party and Elizabeth Bryant of the County of Southampton and State of Virginia of the other party witnesseth that the said William Parker and Polly his wife and Lucy Brown for and in consideration of the sum of one hundred dollars current money of this Commonwealth to them in hand paid by the said Elizabeth Bryant at or before the concluding and delivery of these presents the receipt whereof is hereby acknowledged have granted bargained sold aland in the said tract or parcel of land by these presents they and each of them doth grant bargain sell alien enfeoff and confirm unto her the said Elizabeth Bryant her heirs and assigns forever One certain tract or parcel of land containing twenty four acres being part of the lands of William Bryant the same bounded as follows to w^t west Beginning at a black pine standing in a timbered path a corner for a house to the south James Bryant and Lewis Morris share along said Lewis Morris line 17.65 poles to a post then for a house to the east Lewis Morris share along his line 17.50 11.60 poles to a post a corner for Lucy Brown in said Lewis Morris line then along said Lucy Brown's line 15.17 11.57 poles to the first of said
