of the sum of twenty dollars to them in hand paid by the said William Cobb, the
receipt whereof is hereby acknowledged they the said Chastity Cobb and Benjamin
Cobb have given granted bargained and sold and by these presents do give grant
Bargain and sell unto the said William Cobb his heirs and assigns forever
One certain tract or parcel of land lying and being in the County of Bedford
lying on the south side of the road leading from Samselton to Mapleton's Mill
and is bounded by the said road and by the lands of Lucy Cobb and includes
William Cobb and is supposed to contain five acres more or less and is a part
of the tract of land of which Lazarus Cobb and his heirs and proprie-
tors have and to hold the aforesaid tract or parcel of land unto him the
said William Cobb his heirs and assigns to the only purpose and intent
of the said William Cobb his heirs and assigns forever And the said Chastity
