This Indenture made this 10<sup>th</sup> day of December in the year of our Lord Eighteen  
 hundred and thirty between Elias Summerville and Benjamin L Dyer Commissioner ap-  
 pointed by the County Court of Southampton to sell a certain tract of Land belonging  
 to the estate of Thomas Washington late of New County of the one part and George  
 of the other part Whitefield that the said Elias Summerville and Benjamin L  
 Dyer Commissioner after due consideration of the sum of £ 1000 pounds and  
 Eighty Dollars lawful money of Virginia to them in hand paid or deemed to be paid  
 by the said George Gay before the sealing and delivery of these presents the receipt  
 whereof is hereby acknowledged having been and sold and by these presents  
 do bargain and sell unto the said George Gay his heirs and assigns a certain tract  
 or parcel of Land as mentioned in the decree appointing said Commissioner to sell  
 the Land belonging to the estate of Thomas Washington and all the land belong-  
 ing to said Washington at his death estimated at one thousand and fifty acres  
 to the same man or less and bounded by the lands belonging to the estate of  
 Ethelinda Washington James Washington George Branch Walter G. Brattell Esq.  
 Bryton and Anthony Andrews and the remainder and reversion remaining to any  
 remainder yearly and other rents issues and profits thereof and every part and  
 parcel therof to have and to hold the said tract of Land with the tenement  
 hereditaments and all and singular other franchises hereditaments or  
 intended to be bargained and sold and every part and parcel thereof with every  
 of their rights members and appurtenances unto the said George Gay his  
 heirs and assigns free from the claim or claims of whom the said Elias Summerville  
 and Benjamin L Dyer or either of them and item him and of all and every  
 person and persons who or whom shall well and we warrant and for ever defend  
 all the right title and interest existing in them as Commissioners and no more  
 by these presents In witness whereof the said Elias Summerville and Benjamin  
 L Dyer have hereunto set their hands and seals the day and year above written
