 sell, remise release and confirm unto the said John T. Blom & C all the debts  
 right title interest claims and demands both at Law and in Equity which the said  
 John R. Williams and James Jackson & C have or hold in the said Land aforesaid  
 above To have and to hold the said tract or parcel of Land to the said John T. Blom &  
 Blom & C their heirs executors, administrators and assigns forever to the only, proper, and  
 behalf of them the said John T. Blom & C their heirs Executors administrators  
 and assigns forever and the said John R. Williams and James Jackson & C for  
 themselves their heirs Executors and administrators the above mentioned Land aforesaid  
 the said John T. Blom & C their heirs Executors administrators and assigns in as full  
 ample manner as the same were demanded by the said John T. Blom & C the  
 Deed of Trust above recited do demand the same to the said John T. Blom &  
 against the claim or claims of them the said John R. Williams and James Jackson &  
 & C and all persons claiming by or under them or either of them. In witness whereof
