This Indenture made and entered into on the 31st day of January in the year of our
 Lord Eighteen hundred and thirty one Between John Vick (of Jordan) and Susan his
 wife and John Harrell Trustee to a Deed in Trust executed to him by the said John Vick
 for the benefit of Lewis Worrell bearing date on the 13th day of March 1829 all of the County
 of Southampton and State of Virginia of the one part and Lewis Worrell of the
 same County and State of the other part Witnesseth that the said John
 Vick and Susan his wife for and in consideration of the sum of Two thousand
 and sixty six dollars and twenty five Cents Current money of this Commonwealth
 to them in hand paid by the said Lewis Worrell at or before the making and
 delivery of these presents the receipt whereof is hereby acknowledged have
 granted bargained sold aliened enfeoffed and confirmed and by these presents
 they and each of them doth grant bargain sell alien enfeoff and confirm unto
 him the said Lewis Worrell his heirs and assigns one Certain tract or parcel of Land
 situate lying and being in the aforesaid County of Southampton and Parish of
 Saint Lukes Containing by late Survey fifty three and one fourth acres be the
 same more or less at being ¹⁸²⁷ et. 3rd drawn by said John Vick in the division
 of the Land of his father Jordan Vick dec^d and bounded as follows to wit Beginning
 at a post a corner for John Story in right of his wife in Lewis Vick's line
 thence along said John Story's line at 30th 11 15th poles to a corner in William
 Bryant's line thence along said William Bryant's line at 33th 54 3th poles to a
 post a corner for said William Bryant and James B. and thence along said
 James Bryant's line at 11 1st 6 1st poles to a post a corner thence at 15th 17th poles to a
 post a corner for the aforesaid Lewis Vick thence along his line south 11th 1st 1st
 to the beginning Together with all right title interest claim or demand of law or
 to the aforesaid tract or parcel of Land and premises with its appurtenances
 thence belonging or in anywise appertaining To have and to hold the above
 described tract or parcel of Land and premises with all and singular its appur-
 tenances thence belonging unto him the said Lewis Worrell his heirs and assigns
 forever to and for the only proper use and behoof of him the said Lewis Worrell
 and his heirs or assigns and the said John Vick and Susan Vick his wife
 for themselves their heirs Executors and administrators and assigns that they
 will by these presents warrant and forever defend the right and title of the
 aforesaid tract or parcel of Land and premises and every part and parcel thereof
 against the claims or demands of all and every persons or persons whatsoever And
 the said John Harrell Trustee as aforesaid for himself his heirs and his legal
 representatives doth hereby relinquish all the right and title of the aforesaid tract
 or parcel of Land which was vested in him by virtue of the aforesaid Deed in Trust
 in Witness whereof the said John Vick and Susan Vick his wife
 and John Harrell Trustee have hereunto set their hands and affixed
