borough the receipt whereof is hereby acknowledged have by these pre-
sented bargained sold and released unto the said Sarah Scarborough her heirs
all such right title and interest as was conveyed by her the said Sarah
Scarborough by virtue of the Lease Deed before named to which reference may be
made And the said Nathan A Thomas for himself his heirs assigns
unto the said Sarah Scarborough her heirs &c do warrant and defend the
right and title of the aforesaid property so far as it was warranted to him by
the aforesaid Deed of bargain and sell against the claim and demand of
