 crease Ten head of sheep and their increase also six hairored hounds and furniture
 one sideboard one Secretary and Book Case one Clock and all other my house-
 hold and Kitchen furniture also my entire Crop now sprouting and coming from
 Cotton fodder and oats also my Crop of Corn Fodder and oats now on hand also
 my Crop of Brandy growing atones &c Upon the express Condition for all the
 property herein before mentioned to be sold in order to pay off and discharge the
 amount of monies herein before mentioned to the said William & Jones Thomas
 P Smith and Benjamin Williamson with all and singular the aforesaid
 property herein contained unto the said Lewis Harris his heirs and assigns
 forever to have and to hold the aforesaid property herein before men-
 tioned unto the said Lewis Harris his heirs and assigns forever and the said
 Rebecca Barham do for herself her heirs Executors adms and assigns or monies
 and from following viz that the said Rebecca Barham has her Exec-

 shall after advertising the time and place of sale at least ten days previous
 thereto proceed to sell to the highest bidder for Cash Virginia money the afo-
 resaid property herein before contained and out of the monies arising from such
 sale shall after satisfying the charges thereof and all other reasonable
