 crease Ten head of Sheep and their increase also six or seven head of swine
 one sideboard one secretary and Book Case one Clock and all other my house-
 hold and Kitchen furniture also my entire Crop now preparing and sowing of corn
 Cotton fodder and oats also my Crop of Corn Fodder and oats now on hand also
 my Crop of Brandz farming utensils &c Upon the express Condition for all the
 property herein before mentioned to be sold in order to pay off and discharge the
 amount of money herein before mentioned to the said William & Jones Thomas
 P Smith and Benjamin Williamson with all and singlar the aforesaid
 property herein conveyed unto the said Lewis Harris his heirs and assigns
 forever To have and to hold the aforesaid property herein before men-
 tioned unto the said Lewis Harris his heirs and assigns forever and the said
 Rebecca Barham do for herself her heirs Executors and assigns in manner
 and form following Viz that the said Rebecca Barham has her heirs

 November next and the interest and costs that may have lawfully accrued
 thereon or if a Judgment should be obtained against the said Rebecca Barham

 Harris as Trustee to this Indenture shall at the request of the said Wth
 & Jones Thomas P Smith and Benjamin Williamson securities aforesaid
 shall after advertising the time and place of sale at least ten days previous
 thereto proceed to sell to the highest bidder for Cash Virginia money the aforesaid
 said property herein before conveyed and out of the monies arising from such
 sale shall after satisfying the charges thereof and all other reasonable
 expenses attending such sale pay to the said William & Jones Thomas
 P Smith and Benjamin Williamson their heirs Executors and assigns
