 to the said John M Reale his heirs Executors Administrators and assigns forever to the
 only proper use and behoof of him the said John M Reale forever. In Witness whereof
 that if the said Nicholas Bryant his heirs Executors or assigns shall and beginning
 the said Richard Gray the afore said sum of one hundred and five dollars with
 interest as he shall have occurred thereon or before the time the said Richard
 Gray may or shall require the same the interest and any thing herein contained
 is to be void and of none effect but if the said Nicholas Bryant his heirs
 Executors and does not pay the said sum above mentioned with interest which shall
 have occurred thereon or before the payment of the afore said sum shall be
 demanded as afore said then upon the request in writing either of the said Richard
 Gray &c. Nicholas Bryant his heirs &c. The said John M Reale shall and
 may sell and dispose of the within property named as afore said or such part
 thereof as may be required for the payment of the said sum of money and interest
 at public auction for ready money in the said County given at least ten days
 notice public auctions of time and place of such sale by advertisement posted
 up in at least three public places in the said County and the proceeds of such
 sale after paying and satisfying all costs attending the execution of this Trust
 applied by the said John M Reale to the discharge of the afore said sum of
 due and owing to the said Richard Gray as afore said or so much thereof as may
 then be due together with the interest which shall have accrued and if there
 shall be any surplus of money thereafter remaining in the hands of the said John
 M Reale is to be paid over by the said John M Reale to the said Nicholas
 Bryant in case the said John M Reale should die before the execution of this
 Trust his heirs or assigns to carry this Indenture into effect and perform and
 the said Nicholas Bryant himself his heirs &c. hereby covenant with the said
 John M Reale that the afore said property against the claim or claims of persons
 every person who so ever shall by these presents be named and forever defend
