This Indenture made the 21 day of February in the Year of our Lord 1831
between Richard A. Wright of Southampton County Trustee to a Deed of Trust executed
to him by Thomas R. Gray of the said County for purposes therein mentioned (the aforesaid
Deed of Trust has been duly recorded in the Clerk's Office of Southampton County of the one
part and Richard Williams of the said County of Southampton of the other part
Witnesseth That the said Richard A. Wright Trustee in and Execution hereof
Thousand and one dollars of lawful money of this Commonwealth to him in hand
paid by the said Richard Williams at or before the executing or delivery of these
presente, the receipt whereof is hereby acknowledged, have bargained and sold and by
these presents do bargain and sell unto the said Richard Williams his heirs and
assigns a certain tract or parcel of Land lying and being in the County aforesaid
containing by a recent survey thereunto made and twenty four acres and bounded as
follows Viz by Lands of John Wright Ors of Thomas Gray
Joseph Farmer the lands belonging to the Estate of Henry Prigg Thomas R
Gray and Pat. Lond. reference to a plat hereunto annexed with well shown
the exact boundaries of the above mentioned Land together with all the singular
houses barns buildings Stables yards gardens or other lands Tenements meadows
pastures feeding Commons woods and woods ways waters water Courses privi-
leges profits advantages emoluments hereditaments and appurtenances whatsoever to the
said Land belonging or appertaining or with the same used and enjoyed or accepted
reputed taken or known as part or parcel as belonging to the same or any part
thereof and the reversion and reversions remaines and remainders of each and
other rents issues and profits thereof and of every part and parcel thereof To
have and to hold the said Land with the Tenements hereditaments and all the
singular other the premises herein before mentioned or intended to be bargained
and sold and every part and parcel thereof with every of his rights members
and appurtenances unto the said Williams his heirs and assigns forever
to and for the only proper use and behoof of him the said Richard Williams
his heirs and assigns forever and the said Richard A. Wright Trustee
for himself his heirs the said Land with all and singular the premises and
appurtenances before mentioned unto the said Richard Williams his heirs
and assigns free from the claim of him the said Richard A. Wright Trustee
of his heirs and of all and every person or persons whatsoever shall will and do
warrant and forever defend the same title which was vested in him as Trustee
by the aforesaid Thomas R. Gray and none other by these presents In Witness
whereof the said Richard A. Wright Trustee has hereunto set his hand and seal
