This Indenture made and entered into this 22nd day of February in the year
 of our Lord one thousand Eight hundred and thirty one. Between George J. J. of the County
 of Southampton and State of Virginia of the first part, Lewis Harris Trustee of the
 County and State aforesaid of the second part and John J. J. of the County and
 State aforesaid of the third part. Witnesseth that whereas the said George J. J.
 is justly indebted to the said John J. J. in one written obligation from under
 the hand and seal of the said George J. J. executed on the 22nd day of February
 1831. for the sum of Four hundred and thirty six dollars and two cents and
 on demand the 22nd day of February 1831. And the said John J. J. being bound
 as security for the said George J. J. in thirteen written obligations from under
 the hand and seal of the said George J. J. and John J. J. as one executed
 to Lewis Harris on the 4th day of January 1831. and on demand the same time for three
 hundred and thirty three dollars and 10 cents one executed to Lucy J. J. for one
 hundred and thirty two dollars two executed to Benjamin Williamson one executed
 to William A. Jones one executed to Jesse Houston one executed to Howell Harris
 one executed to James Harris one executed to James H. J. Curator of freight
 Harris dec^d one executed to William A. Wardlaw for one executed to E. J. J.
 one executed to Henry J. J. and one executed to E. J. J. the amount and time
 due not recollated which the said George J. J. is willing and desirous to discharge
 from this Indenture Witnesseth that for and in consideration of the sum of
 one dollar lawful money of Virginia to the said George J. J. in hand paid by the
 said Lewis Harris at and before the making and delivery of these presents the
 receipt whereof is hereby acknowledged by the said George J. J. hath given grants
 warrants and sold and by these presents do give grant bargain and sell unto the said
 Lewis Harris his heirs and assigns forever the following negro slaves to wit Sampson
 Amos Jim Sam later Sam and all her increase Amy and all her increase
 and late and all her increase five feather Beds and furniture three head of horses
 one horse mare one Borne horse and bay filly called nancy and two calves
 still upon the express Condition for as much of the herein before mentioned property
 to be sold in case of default of payment of the before mentioned sum as will pay
 of and discharge the amount of monies herein before mentioned to the said John J. J.
 with all and singular the said negro slaves together with all the other property
 herein before mentioned or in any wise appertaining unto the said George J. J.
 in and to the said negro slaves and all other property herein before mentioned
 To have and to hold the aforesaid slaves and all the other property herein
 before mentioned unto the said Lewis Harris his heirs Executors administrators and assigns
 forever And the said George J. J. do for himself his heirs Executors administrators and assigns
 in manner and form following that is to say that the said George J. J. hereby binds
 binds and assigns the aforesaid negro slaves (namely) Sampson Amos Jim Sam
 later Sam and all her increase Amy and all her increase and late and all her increase
 and all the other property herein conveyed unto the said Lewis Harris his heirs
 Executors administrators and assigns against all and every other person or persons who shall
 shall and will warrant and for ever defend by these presents upon that recollation
 left and upon this express Condition that if the said George J. J. shall fail to
