This Indenture made this 21<sup>st</sup> of June 1821 between Sagar Byant and Elizabeth his wife of the first part and James P. French of the second part Witnesseth that for and in consideration of the sum of Seven hundred dollars the receipt whereof is hereby acknowledged the said Sagar Byant and Elizabeth his wife have bought and sold and conveyed and by these presents do sell and convey unto James P. French his heirs &c forever a certain tract or parcel of land purchased by said Byant & Elizabeth Godwin containing two and a half acres of land lying in the County of Southampton adjoining Jerusalem beginning at a post on the road about two hundred and twenty eight yard from the Corner of piece lot thence back a straight line about at Eight hundred and five yards to a post thence a straight line about at 14 to James Rockelle's line or the post leading from the main road to the old race field. To have and to hold the said two and a half acres of land unto the said James P. French his heirs and assigns forever the title whereof the said Sagar Byant together with
