Williams I bindenture made and entered into this the 14 day of July one thousand eight  
hundred and thirty one between Mattheus Williams of the first part, Lutelton R. Edwards of the second,  
Major Bratfapart and John M. Guley James Rochelle and Jeph Drury of the third part, all of the  
County of Southampton and State of Virginia Whereas the said Mattheus Williams shall  
have taken an execution by the Sheriff of the County of Southampton by virtue of a writ of  
Captioned satisfaction issued from the Clerk's Office of the former Superior Court of  
Law for the said County at the suit of Benjamin White and thereupon the said Mattheus  
Williams having taken the benefit of the prison rules aforesaid and laid out by the said  
County of Southampton and for that purpose hath entered into Bond with the said  
John M. Guley James Rochelle and Jeph Drury his securities with a penalty of  
Eleven hundred dollars and conditioned as the Law directs And the said Mattheus  
Williams being desirous of indemnifying and saving himself the said John M. Guley  
James Rochelle and Jeph Drury from any damage whatever which they may sustain  
in consequence of their being his securities as aforesaid hath Conveyed the property  
herein after mentioned to the said L R Edwards in Trust to be sold for that purpose  
and therefore this Indenture witnesseth that the said Mattheus Williams  
in Consideration of the premises aforesaid as well as for the further Consideration of  
the sum of one dollar to him in hand paid by the said L R Edwards the receipt where  
of is hereby acknowledged he the said Mattheus Williams hath given granted  
bargained and sold and by these presents doth give grant bargains sell and Convey  
to the said L R Edwards his Executor administration aforesaid the following  
property to wit one certain tract or parcel of land wherein the said Williams now  
lives containing three hundred and fifty acres more or less to other tracts of Land  
lying and being in the County aforesaid containing one hundred acres each To have and  
to hold the said several tracts or parcels of land with every thing appertaining thereto  
to unto him the said L R Edwards his heirs Exec'rs adms and assigns to the  
only propriece and chief of the said L R Edwards his heirs Executors adms and  
assigns forever Upon this Special trust and Confidence that whenever the said  
John M. Guley James Rochelle and Jeph Drury or either of them shall have  
actually sustained any loss or damage or concue themselves to be in danger of suffering  
any loss or damage in consequence of the said Securityship it shall and may be lawful  
for the said L R Edwards being trustee required by the said Guley Rochelle and Drury  
or either of them after having given reasonable public notice thereof cause to sale  
at public Auction the aforesaid tracts and parcels of land and premises with all appur-  
tenances to the highest bidder for Costs and out of the monies arising from such sale  
first pay the Costs and expenses of the said sale and the Conveyance in the second  
place pay to the said Guley Rochelle and Drury such sum or sums of money as  
they or either of them may have been compelled to pay or likely to be made to pay  
and the balance if any pay to the said Mattheus Williams or his legal representation  
But if the said Mattheus Williams shall execute and discharge the said Con-  
tract Rochelle and Drury from them said Securityship and pay all Costs and expenses in-  
curred by the said Dues then the same shall be void or due to remain in fee free In witness
