 eight hundred and thirty one between Matthias Williams of the first part L. R. Edwards of the second part and
 John M. Gentry of the third part Whereas the said Matthias Williams is fully indebted to the said John M. Gentry in the sum
 of five hundred and sixty five dollars and ninety eight cents to be paid as follows one
 hundred due the 15th day of September next for one hundred and fifty dollars and ninety
 eight cents one due the 25th December next for the sum of one hundred and fifty
 dollars also another bond due the 25th December 1832 for three hundred dollars
 which said bonds are to carry interest from the date which debt the said Matthias
 Williams is willing and desirous to secure it on this Indenture Whereas
 that for and in consideration of the premises and also for the further consideration of
 one dollar lawful money of Virginia to the said Matthias Williams in hand paid
 by the said L. R. Edwards at and before the sealing and delivery of these
 presents the receipt whereof is hereby acknowledged by the said Matthias Williams
 hath given granted bargained sold aliened enfeoffed released and confirmed and by
 these presents doth give grant bargain sell enfeoff release and confirm to the said
 L. R. Edwards his heirs and assigns forever all that tract or parcel of land
 lying and being in the County of Southampton in the State of Virginia containing
 35 1/2 acres more or less adjoining the land of William Allen Edwin S. Smith
 Orams and others it being the tract of land whereon the said Matthias Williams
