

Southampton County In the Clerk's Office the 19th day of September 1831.
 This Indenture made by the wife of Joseph Lunn one of the witnesses
 and having been proved in the Clerk's Office the 17th day of September 1831 to the
 oath of W H Holden and Willton Guy also witness whereof this indenture is annexed to this
 And at a Court held for the County aforesaid the 17th day of October 1831. The said
 Indenture was entered upon the proceedings of the day.

Deed Indenture made this 1st day of August in the year of our Lord one thousand
 Eight hundred and thirty one. Between Solomon Daughtry and Barbara his wife of the
 County of Isle of Wight in the State of Virginia of the one part and Uriah W Gardner
 of the County of Southampton and State aforesaid of the other part. Whereas it is agreed that
 the said Solomon Daughtry and Barbara his wife for and in consideration of the sum
 of six hundred dollars to them in hand paid by the said Uriah W Gardner at or before
 the ensuing and delivery of these presents the receipt whereof is hereby acknowledged,
 they the said Solomon Daughtry and Barbara his wife have granted bargained and
 sold and by these presents do and each of them doth grant bargain and sell unto the
 said Uriah W Gardner his heirs and assigns a certain tract or parcel of land situate
 and lying in the aforesaid County of Southampton adjoining the lands of Henry
 Jordan Edwards Uriah W Gardner and others marked and bounded as followeth
 Beginning at a pine adjoining the hins of Hindo McHenry &c then west 100
 63 poles to a maple tree 10 rods more East then 168 1/2 rods to a corner of the said
 land then S 33 E 86 poles to a gum in the poplar Island branch then
 up the said branch the several courses of the same 368 poles to a corner of Jordan's land
 then along the said Edwards' line 164 1/2 rods to his corner red oak then N 27
 60 poles to a white oak in Henry's prop line then S 54 E 40 poles to a red oak
 stump then S 62 E 83 poles to a locust then S 10 E 140 poles to a pine a corner of the
 donor land then along the donor line to a post at the road then a straight line
 to the Beginning containing two hundred and twenty three and a half acres more
 left the reservation and reservations remainder and remainder yearly and otherwise
 gives and profits thereof and every part and particle thereof. To have and to hold
 the said tract a parcel of land with the premises and appurtenances thereunto
 unto the said Uriah W Gardner his heirs and assigns forever. And the said Solomon
 Daughtry and Barbara his wife for themselves their heirs the said tract or parcel of land
 with all and singular the premises and appurtenances before mentioned unto the said
 Uriah W Gardner his heirs and assigns free from the claim or claims of them the said
 Solomon Daughtry and Barbara his wife or either of them their or either of their heirs
 and of all and every other person or persons whatsoever will and do warrant and bind
 before these presents. In witness whereof the said Solomon Daughtry and
