Adams at or before the sealing and delivery of these presents the receipt whereof is hereby acknowledged that he has gained and sold and by these presents do bargain and sell unto the said Alfred W. Adams his heirs and assigns a certain tract or parcel of land containing by estimation one hundred and fifty acres be the same more or less and bounded by the lands of Joseph Harris Day Seymour and others on Wades his, it being the tract or parcel of land that Mills Griffin sold to James Johnson, reference thereto being had well more fully appear together with all and singular the appurtenances therunto belonging or in any way appertaining to the same or any part or part thereof.
