 same County and State of the other part. Altesthath that the said Jesse Morrell and Elizabeth
 his wife for and in Consideration of the sum of Thirty dollars Current money of this Commonwealth to
 them in hand paid by the said Jesse Morrell at or before the executing or signing of these presents
 the receipt whereof is hereby acknowledged, have granted bargained sold aliened conveyed and
 confirmed and by these presents do and each of them doth grant bargain sell alien convey and
 confirm unto him the said Jesse Morrell his heirs and assigns forever One Certain Lot or
 piece of land situate lying and being in the aforesaid County of Southampton and Parish
 of Saint Lukes Containing by a late survey One acre, it being the Lot or piece of land
 that the said Elizabeth Chetty formerly Elizabeth Bryant purchased of William Minkins
 and bounded by the land of said Jesse Morrell exclusively as follows to wit Beginning at a post
 in the Lane a corner said Morrell's line thence along his line at 69 E 12 3/4 poles to a post

 to a post a corner thence 21 E 12 3/4 to the Beginning To Have and to hold the above described
