This Indenture made the 1st day of October 1831 Between Richard Booth and Elizabeth his
wife of the County of Surry and State of Virginia of the one part and Wm. Holt of the County of
Southampton and State of Virginia of the other part, witnesseth that the said Richard Booth
and Elizabeth his wife in consideration of Four Hundred and fifty dollars of lawful money
of the Commonwealth to them in hand paid by the said William Holt late before the sealing
and delivery of these presents to each of them doth bargain and sell unto the said Wm. Holt
his heirs and assigns a certain tract or parcel of land in the County of Southampton containing
by estimation One Hundred and twenty acres of land more or less and bounded on the North &
East by the lands of Edward Bailey deceased on the South by the land of Joseph Hart, deceased on
West by the lands of Mary Holloman together with all and singular the appurtenances
of and the rauision and reversion remainder and remainders yearly and other rents
issues and profits thereof and of recompent and penaltie thereof to have and to hold the
said tract of land with the tenements hereditaments, and all and singular other the
premises other the premises herein before mentioned or intended to be bargained and sold
and every part and parcel thereof with every of their rights members and appurte-
nances unto the said Wm. Holt his heirs and assigns forever And the said Richard
Booth and Elizabeth his wife for themselves and their heirs the said land with all
and singular the premises and appurtenances before mentioned unto the said
William Holt his heirs and assigns free from the claims or claims of them the
said Richard Booth and Elizabeth his wife or either of them or either of their
heirs and of all and every person or persons whatsoever shall use and do leavant
and forswear defend by these presents. In witness whereof the said Richard Booth
and Elizabeth his wife have hereunto set their hand and seals the day and year
