of Southampton, a part of the land formerly owned by Jacob Barrett, dec^d containing One Hundred
and forty six acres, by the late Survey it being Lot N^o 3 in the division of said Jacob
Barrett's land and assigned to him by the Commissioners as well as appears by referring to said
Commissioners' Report, together with all the singular appurtenances thereto belonging or in
anywise appertaining To Have and to Hold the said Lot of Land N^o 3 containing One
Hundred and forty six acres as aforesaid to her the said Mary Barrett, her heirs and assigns
forever, to and for the only proper use and behoof of her the said Mary Barrett, her heirs
and assigns forever, and the said Sarah Barrett for herself and her heirs the said One
Hundred and forty six acres of land, with all and singular the premises and appurtenances
