Whereas the said Benjamin Williams is partly indebted to the said Carr Powers in the sum of One hundred and thirty three dollars and Eighty Seven cents to be paid on the 20th day of April next in the year 1830 as by a bond bearing date with these premises more fully appear - which all the said Benjamin Williams is willing and desires to be bound to this Indenture, witnesseth that for and in consideration of the premises and also for the further consideration of one dollar to the said Benjamin Williams in hand paid by the said Gape Lantford Trustee at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged by the said Benjamin Williams Ruth given granted bargained sold and confirmed and by these presents doth give grant Bargain sell and Confirm unto the said Gape Lantford his heirs and assigns for the following personal property in the County of Southampton and State of Virginia (town) One horse or mares as the Case may be One Cart and Whals four head of horned cattle, twenty head of hogs, some feather beds and furniture my bedding (less tables and Kitchen furniture my Copper tools and all my Cun and foder than on hand more or less) To have and to hold the said hereby granted or intended to be hereby granted personal property hereby conveyed into the said Gape Lantford his Executors and Administrators and assigns forever in manner and form following that is to say that the said Benjamin Williams his heirs Executors and Assigns the aforesaid personal property hereby convey'd unto the said Gape Lantford his heirs Executors ad^ms and assigns against all persons whatsoever shall and will remain and forever defend by these presents upon trust nevertheless that
