Examined and Whereas the said Stacey Barrett is justly indebted to the said Dolos in the sum of  
to Patrick Dolos sixty six dollars lawful money of this Commonwealth due by note bearing date the 15<sup>th</sup> day of  
Nov 5/1832 now This Indenture witnesseth that for and in consideration of the sum  
of one dollar of lawful money of Virginia to the said Stacey Barrett in hand paid  
by Benjamin Crumpler Trustee at or before the executing and delivery of these presents  
the receipt whereof is hereby acknowledged by the said Stacey Barrett the debt herein mentioned  
bargained and sold and by these presents doth give grant bargain and sell unto the said  
Benjamin Crumpler Trustee his heirs and assigns forever the following premises to wit  
a certain tract or parcel of land containing seventy two and one third acres to the same more  
or less with all its conveniences and appurtenances and bounded as follows by the land  
of William Bonden Robert Adams Robert Hart Benjamin Crumpler (Holder)  
Summerell and Robert Mercer and the same land that the said Stacey Barrett purchased  
of John Byrd To have and to hold the said tract of land unto the said Benj:  
Crumpler Trustee his heirs Execs and adms and assigns forever and the said Stacey Barrett  
for himself his heirs Execs and adms and assigns doth hereby Covenant promise & agree to  
and with the said Benjamin Crumpler his heirs Execs adms and assigns forever in no  
anner and form following to wit that the said Stacey Barrett his heirs Execs and adms  
assigns the aforesaid tract of land unto the said Benjamin Crumpler his heirs Executors  
Administrators and assigns against all persons whatsoever shall and will warrant and pursue  
defend by these presents upon trust nevertheless that the said Benjamin Crumpler  
his heirs Executors and adms shall permit the said Stacey Barrett to remain in  
quiet and peaceable possession of the above named Land and take the profits thereof
