part. Witnesseth that whereas the Court of Ordinary for the County and State first aforesaid has granted
leave to the Guardians aforesaid to sell certain negroes viz. Tom, Henry and Vinny mentioned in the
above order and for the purposes therein recited. Now for and in consideration of the sum of several hundred
Dollars by the said Peter Edwards to the said William B. Stephens, Thomas B. Shad and Thomas
Perryman Guardians as aforesaid in hand paid the receipt whereof is hereby acknowledged the said
William B. Stephens Thomas B. Shad and Thomas Perryman Guardians of aforesaid have
granted bargained and sold and by these presents do grant bargain and sell unto the said
Peter Edwards his heirs and assigns the following negro to wit Tom, Henry and Vinny their heirs
and to hold the above mentioned negroes to the said Peter Edwards his heirs and assigns forever
And the said William B. Stephens, Thomas Shad and Thomas Perryman as Guardians
aforesaid the said negro unto the said Peter Edwards his heirs Executors and administrators
will warrant and forever defend against the claims of themselves as Guardians and against the
claim of all persons whatsoever In Testimony whereof the said Guardians have hereunto set
their hands and seals the day and year above written
